
**ORDER**

**UPON THE APPLICATION** of Meyers Norris & Penny Limited (the "Receiver"), Receiver and Manager of The Diamond Bullet Corporation, Premiere Manufacturing Ltd., DBC International Inc., Hat Bit Supply Ltd. and R Environmental Labs Ltd.(the "Companies"); **AND UPON** reading the First Report of the Receiver (the "Receiver's First Report"), filed; **AND UPON** hearing counsel for the Receiver and Manager;

**IT IS HEREBY ORDERED THAT:**

1. The Liquidation Proposal of Joiner Sales Corp. attached as Appendix B to the First Report of the Receiver dated May 4, 2009 be and the same is hereby approved.
2. The Receiver be and is hereby authorized to execute and deliver and enter into the liquidation proposal with Joiner Sales Corp. in the form substantially as attached as Appendix B to the Receiver's First Report.

3. The Receiver be and is hereby authorized to make interim distributions from the funds arising from the sale of collateral liquidated by Joiner Sales Corp., in an amount not to exceed the outstanding indebtedness of the Companies to HSBC Bank Canada provided that the Receiver shall not distribute proceeds of liquidation arising from the liquidation of collateral subject to purchase money security interests in favour of General Motors Acceptance Corporation of Canada Limited or Citicorp Vendor Finance Ltd. and, to the extent that there are proceeds of disposition arising from the sale of such collateral, then Receiver shall hold such proceeds into one of the Post Receivership Accounts (as such term is defined in the Order appointing the Receiver granted in the within proceedings on February 26, 2009) with distribution of such proceeds to occur upon further application to this Honourable Court.

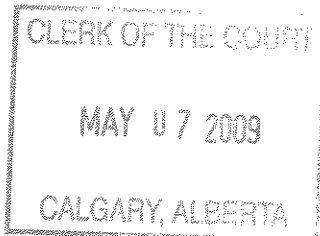
