The Diamond Bullet group of companies filed a Notice of Intention to Make a Proposal ("NOI") on October 27, 2008. The Company failed to file a proposal prior to March 2, 2009 and was deemed to have made an assignment in bankruptcy on March 3, 2009.

Note 2:

During the period October 20, 2008 to March 6, 2009, the NOI Trustee's fees for the Diamond Bullet group of companies totalled \$91,200 plus disbursements of \$6,228.06 and GST of \$4,871.40. The NOI Trustee received payments totalling \$68,888.13 and incurred a shortfall of \$33,411.33.
