TAKE NOTICE that an Application will be made by the Receiver/Manager, Meyers Norris Penny Limited (the "Receiver") herein before the Honourable Madam Justice C.A. Kent, in Chambers, at the Calgary Courts Centre in the City of Calgary, in the Province of Alberta, on Wednesday, the 7<sup>th</sup> day of April, 2010, at the hour of 1:30 o'clock in the afternoon, or so soon thereafter as counsel may be heard, for an Order:

1. Approving the sale of a portion of the assets of the Defendant to Bumper Development Corporation Ltd, Gateway Petroleum Inc. and Tyvan Oils Ltd. and such vesting order that may be proposed by the Receiver as set out in the form attached as Schedule A hereto as may be amended.
2. Providing an order sealing the Agreement of Purchase and Sale between the Receiver and the purchasers until the closing of the sale has occurred.
3. Abridging the time for service of this Notice of Motion as may be required to deem service good and effective.

4. Such further and other relief as this Honourable Court may deem just.

AND FURTHER TAKE NOTICE that the grounds upon which the application will be made are as follows:

- 1 The sale proposed by the Receiver is in the best interests of the administration of the receivership and the stakeholders affected thereby; and
- 2 The relief requested is just, appropriate and in the best interests of the administration of the receivership estate.

AND FURTHER TAKE NOTICE that in support of such application the Receiver will rely on:

- (a) *The second report of the Receiver filed herein;*
- (b) *Bankruptcy and Insolvency Act;* and
- (c) Such further and other materials as counsel may advise.

AND FURTHER TAKE NOTICE that the Receiver will ask for all costs of and incidental thereto.

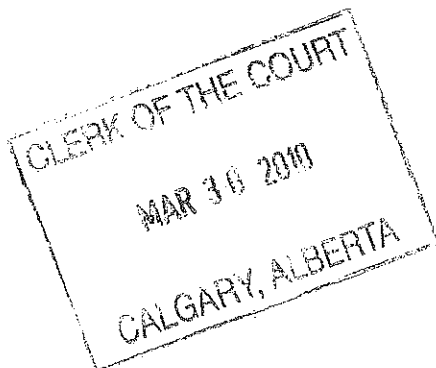
