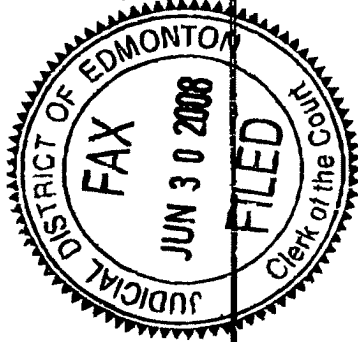


1. Service of this Notice Motion, Affidavit in support and Report to the Trustee on all creditors of Transglobal before the hearing of this motion has been dispensed with;


