THE RECEIVER GIVES NOTICE AND DECLARES THAT:

1. On November 19, 2008, the undersigned Meyers Norris Penny Limited, became the Receiver-Manager in respect of the property of Guild Developments Inc. and 702348 Alberta Ltd., an insolvent corporation, that is described below:
