1. The Amended Ex Parte Initial Order made by this Honourable Court March 27, 2008;
2. The Plan of Arrangement and Compromise dated July 4, 2008, (the "Plan") as approved by this Honourable Court in the Order (Filing of Plan and Meeting of Creditors); and
3. The Order (Sanction of Plan of Arrangement and Appointment of Administrator), made by this Honourable Court September 18, 2008, (the "Sanction Order")

Pursuant to paragraph 11 of the Sanction Order, the Monitor hereby certifies

1. That pursuant to paragraph 62 of the Plan distribution of the amounts to creditors electing to participate in the Immediate Payment Pool (as defined in Schedule A to the Plan) has occurred;
