**FOURTH INTERIM REPORT OF RECEIVER
(Subsection 246(2) of the Bankruptcy and Insolvency Act)**

BACKGROUND

Meyers Norris Penny Limited was appointed as Interim Receiver (the "Interim Receiver") of Talsma's Welding Ltd. ("Talsma's" or the "Company") pursuant to an Order granted by the Court on March 17, 2009 (the "Interim Receivership Order").

The Interim Receiver's appointment was expanded by an Order of the Court granted May 27, 2009 (the "Receivership Order") such that Meyers Norris Penny Limited was appointed as Receiver (the "Receiver") of Talsma's property as defined in paragraph 2 of the Interim Receivership Order.

Subsequently, the Company made an assignment in bankruptcy effective May 29, 2009 and Meyers Norris Penny Limited was appointed as Trustee of the Estate (the "Trustee").

STATEMENT OF RECEIPTS AND DISBURSEMENTS

The Receiver's Interim Statement of Receipts and Disbursements for the period March 17, 2009 to May 20, 2011 is attached hereto as Schedule 1.

STATEMENT OF PROPERTY

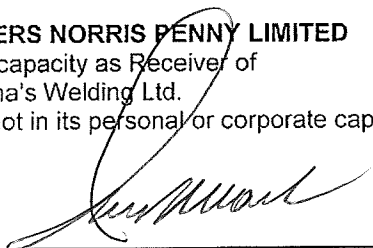
The Receiver has determined that there is no realizable value attributable to the Company's prepaids and deposit account.

The Receiver has not yet realized on certain accounts receivable (approximately \$885,000). Collection action with respect to certain of the remaining accounts receivable (approximately \$765,000) will be handled by the Trustee in conjunction with the various investigative powers afforded to the Trustee under the *Bankruptcy and Insolvency Act*.

Title to the real property located in Bentley, Alberta was transferred to the holder of the first mortgage against the property pursuant to an Order of the Court granted December 16, 2010.
